### **Phase two: Operating in the Courtroom of Heaven/Deliverance**

The learning objective for this section is to bring order and increase effectiveness into the deliverance process

1. Read chapters 10-17 of "*Satan's Rules*"

2. Read "*Issuing divine restraining orders from the courts of Heaven*" Dr Francis Myles, Kindle

A. This will give you some background on the concept of the courts and the way they can be used to interrogate and expel the demons with minimum manifestations.

3. Watch Deliverance videos by Dr. Scott

### **Module 2-A Dr. Scott Bitcon Deliverance Training**

A. Take notes, ask questions to be used in your phone lab with professor Dr Milt Weber

4. Read the Covenant deliverance section from the training manual on inner healing and deliverance section 8 "setting the parameters for the deliverance."

5. Write down your questions for your session with the instructor. If you are new to these concepts you will certainly have questions.

Lab: Each student will have a personal process with the instructor (one to two hours) The Lab will be tailored to the students experience in this area. The best way to understand the dynamics of this process is to experience it yourself.

### **Phase Four: Learn by doing**

1. Reread chapter 15 of "*Satan Rules*"

2. Find a willing subject and take them through the process. (Chapter 15)

3. Lab: Follow up phone call with instruct Dr Milt Weber
